

At close, the Sensex was up 142.87 points or 0.17% at 82,000.71, and the Nifty was up 33.20 points or 0.13% at 25,083.75. About 2,025 shares advanced, 1,886 shares declined, and 145 shares remained unchanged.

At the close on the NYSE, the Dow Jones Industrial Average gained 0.04% to close at 44,938.31, while the S&P 500 index declined 0.24% to end at 6,395.78, and the NASDAQ Composite fell 0.67% to 21,172.86.

On the Multi Commodity Exchange (MCX), gold futures were trading lower at Rs 99,000 per 10 grams, falling by Rs 304 or 0.31%. Silver contracts were trading flat at Rs 1,12,506 per kg, slightly down by Rs 47 or 0.04%.

U.S. West Texas Intermediate (WTI) crude futures rose 15 cents, or 0.24%, to \$62.86. Brent crude futures were up 13 cents, or 0.19%, to \$66.97 per barrel.

The rupee fell by 18 paise to close at 87.25 against the US dollar. At the interbank foreign exchange market, the rupee opened on a positive note at 87.04, touched an early high of 86.93, and an intraday low of 87.27 against the US dollar.
