

At the close, the Sensex was up by 901.11 points or 1.13%, ending the week at 80,710.76, while the Nifty rose by 314.15 points or 1.29%, closing at 24,741.00.

At the close of the NYSE, the Dow Jones Industrial Average was up by 0.17%, ending at 45,621.29. The S&P 500 Index rose by 0.65%, closing the week at 6,502.09, while the Nasdaq Composite Index climbed 1.18%, finishing at 21,707.69 as of 5:30 PM this week.

On the Multi Commodity Exchange (MCX), gold futures increased by 2.78% to ₹1,06,710 per 10 grams. Silver futures were up by 3.17%, settling at ₹1,24,190 per kilogram as of 5:30 PM this week.

U.S. West Texas Intermediate (WTI) crude fell by \$1.29 or 2.02%, to \$62.69 per barrel. Brent crude futures edged lower by \$1.20 or 1.75%, to \$66.27 per barrel as of 5:30 PM this week.

The Indian rupee closed slightly higher by 0.04 paise, at 88.16 against the US dollar. In the interbank foreign exchange market, the local currency opened at 88.12, touched a high of 88.36, and a low of 87.83 against the US dollar during the week, as of 5:30 PM.
