

Benchmark indices closed in the red with Sensex down 567.98 points or 1.02% at 55107.34, and the Nifty falling 153.20 points or 0.92% at 16416.30. About 1261 shares have advanced, 1954 shares declined, and 126 shares are unchanged.

At the close in NYSE, the Dow Jones Industrial Average gaining just 16 points, with no U.S. economic data releases, few major earnings reports and the Federal Reserve policymakers quiet ahead of next week's meeting.

U.S. West Texas Intermediate (WTI) crude futures were up 25 cents, or 0.2%, at \$118.75 a barrel. Brent crude futures were up 19 cents, or 0.2%, at \$119.70 barrel.

The Indian rupee depreciated 5 paise to 77.71 against the US dollar. At the interbank foreign exchange, the rupee opened weak at 77.72 against the US dollar, then recovered slightly to quote 77.71, registering a decline of 5 paise from the last close.
