

At Close, the Sensex ends 635.05 points or 1.03% lower at 61067.24, and the Nifty shed 179.70 points or 0.98% at 18205.60.

At the close in NYSE, the Dow Jones Industrial Average rose 0.28% at 32,849.74, while the S&P 500 index gained 0.10% at 3,821.62, and the NASDAQ Composite index gained 0.01% at 10,547.11.

On the Multi-Commodity Exchange (MCX), gold futures were trading higher by 0.08% at Rs 54,944 per 10 grams. Silver added 0.15% at Rs 69,749 per kg.

U.S. West Texas Intermediate (WTI) crude futures gained 6 cents to \$76.29. Brent crude futures rose 8 cents to \$80.07 per barrel.

The rupee depreciated 5 paise to 82.75 against the US dollar in early trade. At the interbank foreign exchange, the domestic unit opened weak at 82.76 against the dollar.
