

At close, the Sensex was down 8.03 points or 0.02% at 53,018.94, and the Nifty was down 18.80 points or 0.12% at 15,780.30. About 1336 shares have advanced, 1857 shares declined, and 138 shares are unchanged.

At the close in NYSE, the Dow Jones Industrial Average added 0.27%, to 31,029, while the S&P 500 Index declined 0.07%, to 3,819 and the NASDAQ Composite Index fell 0.03%, to 11,178.

On the Multi-Commodity Exchange (MCX), gold contracts were trading flat at Rs 50,728 for 10 grams, while silver added 0.13 percent to Rs 59,140 a kilogram.

U.S. West Texas Intermediate (WTI) crude futures slid 19 cents, or 0.2%, to \$109.58 a barrel. Brent crude futures dropped 25 cents, or 0.2%, to \$116.01 a barrel.

The rupee appreciated 13 paise to 78.90 against the US dollar. At the interbank foreign exchange, the rupee opened at 78.92 against the US dollar.
