

Sensex surging 1,564.45 points or 2.70% at 59537.07, and the Nifty jumping 446.40 points or 2.58% at 17759.30. About 2323 shares have advanced, 1007 shares declined, and 123 shares are unchanged.

At the close in NYSE, the Dow Jones Industrial Average slipped 0.57%, to 32,099, while the S&P 500 Index fell 0.67%, to 4,031 and the NASDAQ Composite Index was down 1.02%, to 12,018.

On the Multi-Commodity Exchange (MCX), gold contracts were trading lower by 0.29 percent at Rs 51,101 per 10 grams, and silver shed 0.7 percent at Rs 53,949 a kilogram.

U.S. West Texas Intermediate (WTI) crude futures dropped 81 cents, or 0.7%, to \$104.28 a barrel. Brent crude futures were down 27 cents, or 0.3%, to \$100.72 a barrel.

The rupee appreciated 7 paise to 79.84 against the US dollar. At the interbank foreign exchange market, the rupee opened at 79.92 against the dollar.
