

At close, the Sensex was down 153.13 points or 0.29% at 52,693.57, and the Nifty was down 42.30 points or 0.27% at 15,732.10. About 1506 shares have advanced, 1730 shares declined, and 132 shares are unchanged.

At the close in NYSE, the Dow Jones Industrial Average declined 2.79%, to 30,517, while the S&P 500 Index fell 3.88%, to 3,750 and the NASDAQ Composite Index declined 4.68%, to 10,809.

On the Multi-Commodity Exchange (MCX), gold contracts were trading 0.27 percent lower at Rs 50,527 for 10 grams, while silver shed 0.35 percent to Rs 60,100 a kilogram.

U.S. West Texas Intermediate (WTI) crude eased 4 cents to \$120.89 a barrel. Brent crude futures dipped 6 cents to \$122.21 a barrel.

The rupee inched higher by 2 paise to 78.02 against the US dollar. At the interbank foreign exchange, the rupee opened at 78.02 against the dollar.
